Type of Search Warrant

Narcotics Complaint

1st Precinct FMT officers responded to 1408 N 26th Street in response to a Citizen Request/Complaint of drug activity. As we pulled up to the residence someone inside shut the front door and a juvenile ran out the back door and jumped the fence into the rear alley. Officers conducted a "knock and talk" and spoke with Sandra Jones (the owner) at the front door there was a very strong odor of marijuana coming from inside the residence. "Plain smell of marijuana" identified herself as an owner of the house; she provided us consent to look around the residence. We had everyone move into the front room and ran their information. We found evidence of drug activity in this house i.e. (baggie corners with residue, roach's in the ashtrays and the very strong odor of marijuana in the house). Melissa Jones had a felony capias on file. She was taken into custody, transported to lock-up and served her capias.

2708 Nine Mile Rd Apt D

Narcotics Complaint

At 1020 hrs on 12/12/2008 a search warrant was conducted on 2708 Apt D Nine Mile Rd. The Offender Identified as John Valentine was present during search warrant. Found inside the residence was a bag with approximately 1.6 ounces of marijuana, digital scales with white residue and US Currency. The Offender had 7 felony and 1 misd warrant in Hanover. And three warrants in Richmond along with two addition felonies

Narcotics/Weapons

SEARCH WARRANT/FIREARMS/NARCOTICS SEIZURE – 2063 CREIGHTON ROAD - 12-30-08 - 1700 hrs: Officers Lindsey and Gilbert conducted a "knock and talk" at 2063 Creighton Rd. After being admitted into the residence a strong smell of marijuana was detected. Also, in plain view, were numerous baggies of marijuana and a baggie corner of crack cocaine in the toilet. A search warrant was obtained. Additional narcotics were recovered (more marijuana, ecstasy, Percocet) along with a scale, packaging material and two semiautomatic handguns (Taurus PT 111 9 mm, S/N: TAU99688 and Smith & Wesson Sigma .40 cal, SN: PAJ8051). The leaseholder (April Minns) and four visitors (Demond Winston, Michael Bowman, Hakeem Terry and Walter Clark) were inside the residence were taken into custody and charged with PWID marijuana, PWID schedule II (ecstasy), possession of crack cocaine, possession of prescription narcotics (Percocet), concealed weapon and maintaining a common nuisance. Sergeant Hixon, of the Narcotics Unit responded.
