*Search Warrants Sector 113*

**SEARCH WARRANT:** 03/05/09, 2034 hours, 3308 Bunche Place. SID detectives executed a search warrant. The front door to the apartment was breached. Heroin and marijuana was seized. Two males were arrested and charged with numerous charges, to include PWID heroin, and PWID marijuana. Scales and documents were also seized.

**Search Warrant, Weapons Seizure X2, Damage to Private Property, 1415 N 20th St,**FMT Officers served a search warrant at the above address. Officers had to breach the door to make entry to the residence causing damage to the door frame. Upon entering contact was made with 2 people 1 of which is the home owner, Shelia HUDSON. During the search of her she had a quantity of Heroin on her packaged for distribution. Also in the house were numerous items related to the distribution and use of heroin and cocaine. During the search a .357 Taurus Revolver and 20guage Mossberg Shotgun was recovered. Ms. Hudson was charged with PWID Heroin, PWID Heroin with a Firearm, Poss Cocaine, Maintaining a Common Nuisance. **Search Warrant/ Damage to Private Property-** On 3-6-09, at 1605 hours, 1st Precinct FMT conducted a search warrant at 1012 N. 20th ST. This was a narcotics paper that was the results of an ongoing investigation. Arrested in the search warrant was Cornelius Mosby, 3/27/74, who was charged with trespass and Poss with intent to distribute cocaine. Also Paulette Artis ( 11/7/64) was written a summons for Poss of Marijuana and maintaining a common nuisance . Seized was a small quantity of crack cocaine, packaging materials, scales, \$1065.00 and a small quantity of marijuana. The front door was the original breach point, but entry wasn't able to be made from the front so the team made entry from the rear. Damage to both front and rear door occurred. Pd- 41 and packet completed. RRHA, Officer Ford and Narcotics were notified.

**Search Warrant/Damage to Private Property 1334A Coalter St.-** On 3/13/09 at 1130 hrs, FMT squads 1 and 2, Ofc Burgess and 1st Precinct Det unit, executed a narcotics search warrant at the above listed address. The residence belongs to Leslie Miller and her boyfriend Robery Hayes, bm 4/26/69. The front door had to be breached with the ram along with two inside bedrooms. Found inside the apartment were several scales, numerous packaging materials and cocaine residue. Mr. Hayes was arrested and charged with PWID. PD 41- Packet was completed.

**Search Warrant, Damage to Private Property, Weapons SeizureX2, 2112 Newbourne Street.** All FMT Officers along with SID served a search warrant at the above residence. The front door jam was damaged when the occupants attempted to close the front door at the arrival of the front perimeter team. The residence was secured. Inside the residence was found a quantity of percocet for distribution and 2 firearms that were both fully loaded. A 12 gauge Mossberg shotgun and a 9 MM High Point semiautomatic rifle was found under the bed. Also drug paraphernalia was recovered. The weapons were submitted for DNA due to the fact that we were unable to determine the possible owner. CAPS responded to the scene, Damage to Property packet completed.

**PERMISSION TO SEARCH/RESIDENCE/ FIREARM SEIZURE- On 3/17/09 at 1500 hrs** - FMT units conducted a knock and talk at 2369 Ambrose. The units received permission to search the residence. Seized was a firearm, .38 revolver, serial number not available. Also recovered was a digital scale, baggies with residue and packaging materials.

### *Significant Arrest*

FMT squad 2 arrested Tiffany Neblett 1/13/88, today, who was wanted on 4 outstanding robbery warrants in sector 113 and the new target zone. She was arrested without incident.

**WEAPON SEIZURE – 2700 T ST. – 0100 HOURS** – Kierra Woodson was stopped for a traffic violation and drugs were observed in her vehicle. Search incident to her arrest revealed a stolen Colt 380 handgun. Mrs. Woodson was arrested by Officer Hill.

**Weapons Seizure, 1300 N 22<sup>nd</sup>.** FMT Officers were patrolling the area when they observed the suspect, Albert TISDALE dropped a small amount of cocaine out the passenger window of the car he was in. Mr. TISDALE had a Smith and Wesson .40 on the floorboard between his feet. Mr. TISDALE was arrested for PWID Cocaine, PWID Cocaine w/ 1000' of a School Zone, and PWID Cocaine w/Firearm.

**Weapons Seizure, 2100 N 29<sup>th</sup>**. FMT Officers stopped a known party that had outstanding warrants who was being pushed in his wheelchair, Levon DAVIS. Mr. Davis had a Contempt of Court warrant and a PB 15 on file. Officers during the course of their investigation observed a bulge in the shirt of the person pushing the wheelchair. Mr. Anthony PETERS was carrying a High Point .40. During the search of his person after the weapon was recovered 2 hits of crack were found on his person. Mr. PETERS was charged with Poss Cocaine, Poss Firearm and Narcotics, Concealed Weapon.

**FIREARM SEIZURE** – 3/3/2009, 1756 HOURS, B2300 Rosetta Street Officers Lewis and Perez was walking the Fairfield Court and witness a vehicle traveling east on Rosetta St. with very loud music. The officers conducted a traffic stop. During the traffic stop the offender, Steven Antonio Grantham, Jr, BM, 18 yoa, open the driver's door to gather his ID and to show Officer Lewis his speakers at that time Officer Lewis observed a holster under the seat. Officer Lewis asked Mr. Grantham to step out of the vehicle. While exiting the vehicle he stated that he had a gun in his pants. A Walther .22cal semi-automatic pistol, model#P22, Ser# NO78646 was retrieved from his left pants pockets and 10 .22cal bullets in his right front pants pocket. An additional 48 .22cal bullets were in his left jacket pocket in a clear plastic bag. He was arrested for Concealed Weapon and Loud Music.

**FIREARM SEIZURE-** On March 31, 2009 at 1600 hours, FMT squad 2 arrested Shawn Grenshaw, 7-26-83 in the 2300 block of Carmine St for possession of marijuana and a possession of a concealed .40 caliber Glock handgun, Smithfield model, serial # of US193470. The offender was charged and taken to lockup.
