Search Warrants Sector 113

Officer Collins and Officer Perez responded to a call at in the 1900 block of Accommodation St. The offender, age 86, was seen by Officer Perez waving a gun in the air. The officers approached the offender and recovered the weapon. Based on the offender's statements and other information, the offender was charged Possessing a lock blade knife over 3 ¼ inches, Discharging a firearm, and Brandishing a firearm. As a result of the search warrant, a billy club, a knife, six shot gun shells and, a silver 38 revolver handgun with no serial number were recovered.

1925 Redd St.

While assisting unit 111 on a armed wanted person call at the above address the leaseholder gave consent to search her residence for the wanted person. Once inside of the residence in plain view in a bedroom was a large clear plastic bag of marijuana. The leaseholder signed a consent to search form.

The following items were recovered

- 1) one plastic bag containing leaf like substance
- 2) One Rugar Semi Auto Handgun .45 Cal.
- 3) One Sock containing several rounds of ammo
- 4) One .40 Cal revolver hand gun
- 5) One large clear plastic bag containing several spent, and several none spent cases.

Arrests were conduct for the following crimes:

Possession of marijuana with intent to distribute

Possession of a concealed weapon



Narcotics Detectives executed search warrants at 1312 and 1314 N. 21st St. Approximately 1710 grams of marijuana, 15 grams of crack, 19 grams of heroin, \$875, scales and packaging materials were seized from 1314. The target, was not present during the execution of the search warrant, but warrants for PWID Heroin, Cocaine and Marijuana have been obtained.

Significant Arrest

Narcotics Detectives arrested an individual for outstanding distribution indictments in the 1800 block of N. 20th St. The offender is a dealer in the Creighton Court area.

FMT Officers were on patrol in the Whitcomb Court area when they spotted a subject with long braids trying to run away from them. They kept the subject in sight and observed him remove his braid wig and continue to run away, eventually he was captured. The subject, had 6 outstanding felony warrants reference to a home invasion at 2332 Bethel Street. Search incident to arrest the subject had a about 16 rocks of imitation controlled substances packaged for distribution, peanuts.

CHECKPOINT- 2000 MECKLENBERG. FMT Officers along with FFI and several Evening Shift officers conducted a checkpoint. The checkpoint was run

from 2145 to 2315 hours. 93 cars came through resulting in 16 OVM's, 2 OVF's, 2 Felony Warrants and 1 vehicle pursuit.
