# PRESIDENT'S MESSAGE



### Proposed Church Hill Goals & Strategic Plan 2009 – 2010

Alice to the Cheshire Cat ... "Which road should I take, I am lost and don't know where I am going". Cheshire Cat to Alice, "If you are lost and don't know where you are going - any road will do."

Building on the accomplishments of the past and realizing the opportunities in our community, I believe we should establish strategic goals and strategies for a bright and fruitful future for CHA. This approach is superior to reacting to issues and short-term troubles, which seem to now consume much of our time and energy. If there were strategic goals that acted as guidepost or beacons, then CHA Board and membership could be better focus and set direct paths to achieving them for the ultimate long-term benefit of the whole community. As such I propose below five main goals be established for the balance of the 2009 and set a suggested general courses of action for CHA in 2010. Of course all these goals and ideas of this Strategic Plan will need to be discussed and approved by the membership, thus I am proposing the following for everyone's consideration.

### Overarching Goals and Strategies to achieve the goals

### $Goal\ 1-Increase\ awareness,\ appreciation\ and\ membership\ strength\ for\ the\ CHA\ and\ improve\ its\ leadership\ role\ in\ the\ community.$

Development of a two-year membership attainment plan, emphasis on acquiring new memberships north of Leigh Street and east of 30<sup>th</sup> Street.

Develop a working CHA calendar of events, programs and opportunities on the website and Newsletter and share with CHPN to be more dynamic, interactive and informative.

CHA work at established a corporate outreach programs that links CHA in support recognized charities and other universal needs in our community

Tell a positive story featuring a citizen/resident/event each month in the Newsletter

### Goal 2 - Gain greater respect and improve communications leverage with local, City and State officials.

Establish two specific Board positions, (from present positions), that are title and focus in important work/activities in these areas:

Grant writing, (historic, social and general) and fund raising.

Director of Communications and Community Issues (more involvement, time and efforts directly related to the City, surrounding Counties and Regional approaches).

Research Grant projects and opportunities for access to Federal, State and organizational free funding to support our parks, historic districts and formal/informal community based education programs in the CHA community

Increase partner ships with 7<sup>th</sup> District Rep and all associations in Church Hill – including immediate communities/neighborhoods that are typically under served and under represented

Improve our interactions and inter-relationship with local police, fire fighters and social service providers in our community.

### Goal 3 - Enhance relationship and communications with other associations, schools, churches, businesses, and civil leaders in the Church Hill area.

Create a mentor program for schools and youth from the vast educational and teaching experiences of membership in CHA

Outline a supporting local business program that features local business/establishments each month in the Newsletter, (owners/products and services - not endorsements but informational).

### Goal 4 - Encourage membership participation in CHA and their involvement in events, meetings and public service projects.

Develop community awareness and fund-raising plans in association with the annual major Church Hill festivals Start a Church/Union /Chimbo Earth Day celebrating in nature, parks and recreational activities

Support environmental programs in our community like Tricycle Gardens, Planter's Society and Friends of the Parks.

Develop a new marketing plan and budget to include funding for:

A valued CHA identity that symbolizes a whole community

New web site that is more interactive and dynamic

### Call for Volunteers

The Church Hill Zoning Committee is in need of both a Chairman and committee members. Following are the requirements of both. Please contact John Johnson at mksml@msn.com if you are interested. Thank you.

It is the responsibility of the Zoning Committee to research and advise the Board of Directors on zoning and land use matters in the city of Richmond related to the St. John's, Church Hill North, and Chimborazo Old and Historic Districts. The Chair of the Zoning Committee is appointed each year by the President and approved by the Board of Directors. In selecting a Chair, the incoming President should give strong weight to experience in zoning matters as well as leadership credentials and potential. Committee members should be appointed annually by the Chair after consultation with the President and with the approval of the Board. All committee members so selected shall be members in good standing of the Association and reside in or near the St. John's, Church Hill North and Chimborazo Old and Historic Districts and remain so as to both requirements during their term. The Zoning Committee meets each month in or near the Historic Districts at the call of the Chair, preferably one week prior to the monthly meeting of the Board of Directors. The meetings should be open to observation by members in good standing of the Association, preferably upon notice to the Chair. If any committee member fails to attend four meetings in a one-year period, the Chair shall be empowered to recommend to the President that the member be replaced in the same manner that any other member is appointed.

### Guard against the novel H1N1 flu virus

Flu season is here. Have you been vaccinated? The novel H1N1 flu is a new flu strain that is spreading worldwide among people, particularly school children and young adults. Controlling the spread of H1N1 flu is everyone's responsibility. The Virginia Department of Health urges you to protect yourself, your family and the community against the H1N1 virus by taking these steps:

Vaccinate children and yourself for seasonal flu early and be sure to also get the H1N1 flu vaccine when it becomes available.

Wash your hands frequently and cover coughs and sneezes with a sleeve, elbow or tissue – not your hands. Alcohol-based hand sanitizers are also effective.

Stay home if you have flu symptoms such as fever, cough or sore throat. Don't return to work or school until you have been without a fever for at least 24 hours without the use of a fever-reducing medicine. Working parents should make plans for their children's care if they or their children should become ill with the H1N1 virus.

The U.S. Centers for Disease Control and Prevention recommends that the following groups of people receive the novel H1N1 flu vaccine when it first becomes available:

Pregnant women

People who live with or care for children younger than 6 months of age

Healthcare and emergency medical services personnel Persons between the ages of 6 months and 24 years old People 25 through 64 years of age who are at higher risk because of chronic health disorders or compromised immune systems





### THE CHURCH ASSOCIATION BY-LAWS

### **DRAFT AMENDMENTS, FALL 2009**

### ARTICLE I. NAME

The name of this organization shall be The Church Hill Association.

### ARTICLE II. PURPOSE

The purpose of this organization shall be to promote a sense of unity and common endeavor among all the residents of the St. John's Church, Church Hill North, and Chimborazo Old and Historic Districts, District, other residents of the East District, and other interested persons, in order to develop a stable, desirable urban neighborhood.

### ARTICLE III. MEMBERSHIP

- 1. Membership shall be open to everyone living in and/or working in the St. John's Church, Church Hill North, and Chimborazo Old and Historic Districts, Other residents living and/or working in the East District, and to other interested persons. Membership shall in no way be exclusive.
- 2. Members shall be those persons who have paid their dues during the current calendar year, being <u>JanuaryNovember</u> 1 through December 31. Only members shall be entitled to vote upon any question before the general membership. <u>Any new member who pays their dues after June 1 of any year shall remain a member in good standing until December 31 of the subsequent year.</u>
- 3. Each member shall have one vote. Proxy voting shall not be allowed.
- 4. An up-to-date membership roster shall be maintained by the Membership Committee Chair and verified by the Assistant Treasurer. The roster shall be available at each general meeting.

### ARTICLE IV. OFFICERS AND THEIR DUTIES

- 1. The officers of the Association shall be a President, Vice President, Secretary, Treasurer, and Assistant Treasurer. These five (5) officers and five (5) Directors at Large shall constitute the Board of Directors of the Association. The Board of Directors shall meet regularly each month and at the call of the President. At each meeting of the Board of Directors, the agenda for the membership meeting which follows shall be prepared and approved by the Board. Meetings of the Board of Directors shall be open to any current member of the Association on a non-voting basis.
- 2. All persons nominated to office and holding office in the Association shall be members as defined in these bylaws. All persons elected to office in the Association shall maintain their membership status through their term of office.
- 3. The President shall be the executive officer of the Association and the presiding officer at meetings of the Association and of the Board of Directors.

The President may represent the Association at civic and other public functions. The President shall act as the spokesperson for the Association when directed to do so by the membership of the Association.

The President shall have the authority to engage in correspondence on behalf of the Association. <u>Subject and, subject</u> to the approval of the Board of Directors, <u>the President shall</u> have authority to execute contracts <u>and act as the spokesperson</u> for<del>on behalf of</del> the Association.

The President shall, subject to the approval of the Board of Directors, appoint the chairs of all the standing committees of the Association including such vacancies as may occur. The President may serve as an ex officio member of all standing committees.

- 4. The Vice President shall act for the President in case of the absence of the President, and shall be responsible for the Holiday Festival. Christmas Festival and the presentation of programs at membership meetings. The Vice President shall perform such other duties as the President or the Board of Directors may assign.
- 5. The Secretary shall be responsible for the recording of the minutes of all meetings both of the Board of Directors and of the membership of the Association and shall be responsible for insuring their publication in the newsletter of the Association.

The secretary shall maintain a list of active <u>positions adopted by resolutions or letters of position on</u> the <u>membership. Association's website.</u> Unless stated otherwise <u>at within</u> the <u>time of adoption, resolution</u>, all <u>formal positions adopted by the membership resolutions</u> shall expire <u>and be removed from the active list</u> one year after adoption, <u>or at such time as the issue is resolved by a legislative body.</u> A <u>formal position resolution</u> may be renewed by majority vote of the membership.

The Secretary shall perform such other duties as the President or the Board of Directors may assign.

6. The Treasurer shall collect all the funds of the Association and disburse the funds as stated in Article IX, Section 6, and maintain accurately the financial records of the Association, and shall be a signatory on all accounts of the Association. The Treasurer is responsible for preparing and filing all relevant tax filings and for the upkeep and renewal of Directors & Officers Insurance. The Treasurer shall will ensure that an independent audit of the Association's books is made in April before the new Treasurer assumes office. The Treasurer shall perform such other duties as the President or the Board of Directors may assign.

The Treasurer shall prepare a draft budget for presentation to, and approval of, the Board at its meeting September. The draft budget shall contain statements of proposed expenditure for both operating expenses and community projects and shall be subsequently published in the October newsletter of the Association in order to solicit comment from the Membership. The budget shall then be presented for an official vote at the November membership meeting.

- 7. The Assistant Treasurer, assisted by the Membership Chair, shall maintain an up-to-date roster of the membership; suchmembership, which roster shall be available at all membership meetings. The roster shall include basic contact information such as name, address, phone, e-mail, initial date of membership. The Assistant Treasurer meetings, and shall perform such other duties as may be delegated by the Treasurer. The Assistant Treasurer shall perform such other duties as the President or the Board of Directors may assign.
- 8. The Directors at Large shall perform such duties as may be assigned by the President or the Board of Directors.

### ARTICLE V. NOMINATIONS, ELECTIONS, AND TERMS OF OFFICE

- 1. A Nominating Committee shall be appointed by the Board of Directors at its MayMarch meeting. The committee shall will be composed of two current members of the Board of Directors and two persons who have not served on the Board for at least twothree years. No person who shall be a candidate for office shall serve on the Nominating Committee.
- 2. A slate of officers and Directors at Large shall be presented by the Nominating Committee at the <u>SeptemberApril</u> meeting of the membership. The slate of officers and Directors at Large shall be published in the <u>OctoberMay</u> newsletter. Nominations may be made from the floor at the membership meetings in <u>SeptemberApril</u> and <u>October</u>.

May. All nominees shall be members of the Association at the time of their nomination.

3. Elections shall be held at the <u>NovemberMay</u> membership meeting, after the nominations are closed. <u>Voting will</u> Where there is more than one candidate for an office, ballots or another suitable method of counting votes may be <u>held by ballot.employed</u>. Where there is one candidate only for an office, that candidate may be elected, upon motion properly made and seconded. <u>seconded</u>, <u>by acclamation</u>.

- 4. <u>The Where written ballots or other method of counting votes is used, the President shall appoint twothree tellers to assist in the vote count. The results of the vote shall be announced before the adjournment of the <u>November May Meeting.</u></u>
- 5. All officers shall be elected by a majority of those members present and voting. All Directors at Large shall be elected by a plurality of those members present and voting.
- 6. Terms of office for all officers and Directors At Large shall run from <u>January 1June I</u> to <u>DecemberMay</u> 31. The term of office for officers shall be one (1) year, and the term of office for Directors At Large shall be two (2) years. Two (2) Directors at Large shall be elected in even years and three (3) Directors at Large shall be elected in odd years.
- 7. In the event the President is unable to complete his term, the Vice President shall succeed to the position of President for the remainder of the unexpired term and shall be eligible for nomination and election to the office of President in the year immediately following such succession.

In the event any other officer or a Director at Large shall fail to complete their terms, the Board of Directors shall propose replacement officers or Directors at Large to the membership at the next membership meeting, and the membership of the Association shall elect a replacement. Nominations may also be made from the floor for such replacement and elections held pursuant to the provisions of this article.

8. The Vice President and Assistant Treasurer shall automatically succeed the President and Treasurer, respectively, in the year following their tenure as Vice President or Assistant Treasurer.

### **ARTICLE VI. MEETINGS**

- 1. Regular meetings of the membership shall be held in the months of September, October, November, January, February, March, April, May and August. May.
- 2. The President of the Association may call special meetings of the Association, other than regularly scheduled meetings. The President shall also call a special meeting of the Associationmeetings, or, upon receipt of a petition signed by fifteen (15) members of the Association so requesting requesting, shall call such a special meeting. The petition shall state the purpose for which the meeting is requested.
- 3. Ten percent (10%) of the members of the Association, but no less than twenty (20) members, shall constitute a quorum for membership meetings. A majority vote of the members present at any meeting shall be necessary to pass any measure, except as provided for in Article V, section 5, regarding the election of Directors at Large.

### ARTICLE VII. BOARD OF DIRECTORS

- 1. The Board of Directors shall meet regularly each month and at the call of the President. The President shall preside at meetings of the Board. In order to constitute a quorum six members but shall only vote in case of a tie. A majority vote of the Board shall be present. A constitute a quorum. A majority of the Board members present shall be required to pass any measure.
- 2. The Board of Directors shall be responsible for the ongoing operation of the Association. Once the budget is approved at the November membership meeting, the Board may not expend more than five hundred dollars (\$500.00) in excess of any amount in the approved budget without the approval of the membership at a membership meeting.

Any proposal for spending amounts over five hundred of one thousand dollars (\$500.00)(\$1,000) or more must be announced to the membership by newsletter and electronic communication or flyer before any action of approval at a membership meeting. It is further provided that in any membership vote on spending amounts over five hundred dollars (\$500) or more, in this connection, there shall be strict adherence to permitting only eurrently paid members in good standing to participate, by reasonable safeguard.

The Board shall not act without the approval of the membership, as evidenced by resolution duly moved and seconded at the membership meeting, on the selection of community projects to which Association monies or volunteers will be committed; on changes to the by-laws of the Association; on correspondence espousing support for political or social causes or movements; or supporting or opposing land use issues. Upon the passage of such resolution, the Board may act to carry out the will of the membership as expressed in such resolution.

3. If any officer or Director at Large misses three consecutive or a total of six meetings, the Board of Directors shall be empowered to recommend to the general membership that the officer or Director be replaced. Any Board member desiring to resign shall submit a letter of resignation to the remaining Board members.

### ARTICLE VIII. COMMITTEES

1. The following shall be the standing committees of the Association: Budget, Zoning, Membership, and Holiday Christmas Festival. The Chair of each standing committee shall be appointed by the President and approved by the Board of Directors.

Each Chair so appointed shall then appoint all such committee members as may be necessary to effect the work of the committee.

The Board of Directors shall prepare a statement for the guidance of each standing committee; however, the Zoning committee shall meet on the fourth Tuesday of each month. Moreover, the Zoning Committee shall be have the authority to request, without further approval by the Board or Membership, one month's delay or continuance from the Commission of Architectural Review (the "CAR"), on behalf of the Association, regarding items on the CAR agenda under the following circumstances:committee.

- 1. Requests for zoning changes or Special Use Permits
- 2. New construction
- 3. Changes to footprint, façade or roofline of existing structures.
- 4. Change to setback requirements."
- 2. The President shall also appoint, subject to the approval of the Board of Directors, an Editor of the Association's newsletter, Block Leader Chair and, Memorial Day Festival Chair, and such other positions as may be deemed necessary to carry out the purposes of the association.
- 3. The immediate-past president may serve as an ex officio non-voting member of the board for a one year term. The chair of the Zoning Committee and Editor of the newsletter shall serve ex officio as non-voting participants at meetings of the Board of Directors. The other officers of the Holiday Christmas Festival shall be appointed by the Festival Chair subject to the approval of the President, except the Treasurer who shall be the regularly elected Treasurer of the Association.

### ARTICLE IX. CONTRIBUTIONS AND FINANCES

- 1. The fiscal year shall run from January 1 through December 31.
- 2. The amount of membership dues may be changed upon the recommendation of the Board of Directors and approval by vote of the membership.
- 3. The membership shall vote at the November membership meeting on the budget prepared by the Treasurer. The budget submitted by the Treasurer shall contain both an operating budget for the day-to-day expenses of the Association, and a special projects budget which shall detail any proposed expenditures of Association funds for community, civic, cultural, and/or historic preservation and/or any other special purpose. No funds shall be expended by the Association unless first approved by the membership as part of the budget, except as provided in Article VII, section 2 above.
- 4. The Treasurer shall receive all dues and all other receipts and deposit them in a banking account of the Association. A portion of the association's cash assets may be invested in an interest bearing account.

- 5. The Board of Directors shall have the authority to authorize the expenditure of monies from the Association's operating account as set out in an approved budget, subject to the provision of Article VII, section 2 above.
- 6. The Treasurer shall be authorized to sign any checks under \$200. Checks in the amount of \$200 or more require two signatures, the <u>Treasurer and either the</u> President or the, Vice President or the,
- 7. Requests for community project and capital funds over one thousand dollars (\$1000.00) must be completed in writing and submitted to the Board prior to the approval of the budget, as stated in Article IV, Section 6.

### ARTICLE X. PARLIAMENTARY AUTHORITY

1. Roberts Rules of Order, Current Edition, shall govern the operations of the Association in all cases to which they are applicable and in which they are not inconsistent with these by-laws. These by-laws shall govern in case of such inconsistency.

### ARTICLE XI. AMENDMENTS

These by-laws may be amended at any meeting of the Association by a vote of two-thirds of those present, provided that the proposed amendments have been submitted in writing to the members at least 10 days prior to the date of the regular or called membership meeting. Such submission of the proposed amendments shall be either—by mail, newsletter, or electronic communication. by the means ordinarily used to distribute the newsletter.

Guidance Statement for the Zoning Committee of the Association

Under Article VIII, section 1, paragraph 3 of the By-laws as amended, the Board of Directors is to prepare a statement for the guidance of each standing committee. This document is to provide such a guidance statement for the standing committee on zoning based upon the recommendations of the 1995-96 Zoning Committee and the deliberations of the 1995-96 Board of Directors. While this is provided as a guidance document, it is hoped that it will be viewed by future Boards of Directors and Zoning Committees as reflecting the serious intent which produced it.

- 1. Given the priority for the Association of zoning and land use matters, there should be standing committee status for a Zoning Committee on an ongoing basis.
- 2. It shall be the responsibility of the Zoning Committee to research and advise the Board of Directors on zoning and land use matters in the city of Richmond related to the St. John's, Church Hill North, and Chimborazo Old and Historic Districts. Districts.

- 3. The Chair of the Zoning Committee shall be appointed each year by the President and approved by the Board of Directors. If the Committee deems it useful to its operations, it may wish to designate a Vice-Chair to act as an alternate for the Chair and/or a Secretary to record minutes and assist in correspondence. In selecting a Chair, the incoming President should give strong weight to experience in zoning matters as well as leadership credentials and potential, with preference to members of the previous year's Zoning Committee.
- 4. Experience has taught that the Zoning Committee requires a mix of experience and fresh ideas, geographic and other diversities and a size of membership large enough to enable performance but not so great as to become unwieldy. While the Committee has functioned with varying sizes of membership, an optimal number may be nine, including the chair. A reasonable balance of diversities and of experience is essential; to that end, in a committee size of nine, it seems desirable to bring in at least three fresh members each year and retain as many as six from the prior year. It also seems desirable to include within the nine members, two or more Board members on the Zoning Committee.
- 5. Just as continuity is important because of the demands of the subject matter for the Zoning Committee, it is also important that the Committee not become hidebound by lack of turnover. To that end, term limits for service of, e.g., no more than three years service in any five-year period would be an important safeguard.
- 6. Committee members should be appointed annually, with due regard to the foregoing, by the Chair after consultation with the President and with the approval of the Board. All committee members so selected shall be currently paid members in good standing of the Association and reside in or near the St. John's, Church Hill North and Chimborazo Old and Historic Districts and remain so as to both requirements during their term.
- 7. The Zoning Committee should normally meet each month in or near the Historic Districts at the call of the Chair, preferably one week prior to the monthly meeting of the Board of Directors. The meetings should be open to observation by currently paid members in good standing of the Association, preferably upon notice to the Chair.
- 8. Delinquency. If any committee member fails to attend four meetings in a one-year period, the Chair shall be empowered to recommend to the President that the member be replaced in the same manner that any other member is appointed.

A Church Hill resident brought up to the membership the possibility our local Fire Department being under staffed and, in some cases, inoperative as much as 10-12 days out of the month. This is a real concern as our next closest Fire Station is located on P Street south of the river. Residents plan to post information on the CHA website and Church Hill People News.

Police/Crime Report showed from 7/1/2009 through 8/31/2009: 50% decrease in total violent crimes from the same period a year ago, and an 80% increase in total property crimes from the same period a year ago. Residential burglaries and theft from vehicles were the prime culprits. Please always continue to remove all valuables from sight in your vehicle. Any questions or concerns, please call the First Precinct at 646-0572.

### **Presentations**

Several administrators from ChildSavers spoke to the membership about the need for a Special Use Permit (SUP) in regard to traffic and an overabundance of vehicles surrounding the building. ChildSavers also wants to open on Saturday from 9am-5pm to accommodate more children. The economy has found this resource is in greater need in our area. By comparison, ChildSavers provided 2,000 hours of assistance in 1999 whereas now they provide 8,000 of direct services hours for children in need and their families.

Neighbors expressed their concern about the administrators not presenting these changes to the adjacent homes that surround the ChildSavers building. Parking, noise and traffic were all concerns expressed by the residents that live in immediate area. The membership recommended sending the proposal back to the local neighbors and ChildSavers to work out an agreement more acceptable for all involved. The SUP will then be presented to the Zoning committee. The SUP will also be presented to the Planning Commission in October.

### **Committees**

Treasurer: John Whitworth and Susan White are working on the proposed 2010 budget and it will be presented in the next newsletter.

Membership: Benedicte Whitworth announced that we currently have 342 members in the CHA. The annual membership party is November 24<sup>th</sup> at the 2300 Club.

Zoning: The Zoning committee is in need of new members including a chairman due to some recent resignations.

Holiday: Eugenia Anderson-Ellis spoke to the membership about the upcoming Holiday House Tour and Weekend. The weekend will be held December 11, 12 and 13 with the underlying theme of the 1800's. Currently there are six houses on the tour with a maximum of 10 being accepted. The House Tour on the 13<sup>th</sup> will also consist of opening the Libby Hill Park house where all the past framed Holiday Weekend posters will be displayed by Holly and Chuck Wren. Refreshments will also be served at the Park House. Thanks for your efforts!

Business: The Chimborazo playground has been built and it looks fantastic! On Building day, over 300 volunteers along with Home Depot employees and members of the Joe Gibbs Race Team were all on hand to help. Area restaurants like the Hill Café, Buzzy's Beanery, Sette, Patrick Henry's and Poe's Pub just to name a few all provided food for the volunteers. Thank you to Kaboom and everyone involved in this process and the ultimate unveiling of an area the whole neighborhood can enjoy. The volunteers also built 18 community gardens for the neighborhood.

The Board recommended for John Whitworth to fill the vacated Vice President position, the membership had discussion, a motion to approve which was seconded, and then there was a vote by membership. The motion was carried. The Board recommended for Gene Henley to fill the vacated Director at Large position, the membership had discussion, a motion to approve which was seconded, and then there was a vote by membership. The motion was carried.

The City Parks and Recreation department has been asked to clear out the area below Chimborazo Playground to enhance the Free Flight Bird Park being planned for the area.

The meeting was adjourned at 8:55 pm.


### John Vetrovec, Director at Large



### Confederate Soldiers and Sailors Monument: "the statue would of necessity be Colossal" (Part 2)

This is the second part of a two-part series begun in the last issue of the CHA newsletter. It is excerpted from an article in the Museum of the Confederacy Magazine and lightly edited by CHA member Waite Rawls. In part 1, the Soldiers and Sailors Monument Association had been started in 1887 but had been unable to reach agreement by 1893 with the chosen artist—Richmond native, VMI graduate, and world-famous sculptor Moses Ezekiel.

### "Relieved of all embarrassment..."

Six years had passed since the starry-eyed formation of the Confederate Soldiers & Sailors Monument Association, and the officers had little to show for their efforts, save an unfinished stone base. McCarthy turned to another Virginia -born artist, William Ludwell Sheppard (1833-1912). A savvy commercial artist, Sheppard had trained in New York and Paris, and ably illustrated McCarthy's popular 1884 work, *Detailed Minutiae of Soldier Life in the Army of Northern Virginia*.

More importantly, Sheppard was also a sculptor who had recently completed two Confederate statues in Richmond – one on Park Avenue in the Fan to the Richmond Howitzers



artillery (the unit in which both Sheppard and McCarthy had served) and the other on Laburnum Avenue to Lt. Gen. A. P. Hill. Sheppard immediately set to work executing a model that fulfilled the Committee on Design's requirements—sans internal spiral stairs or colossal decoration. The association board unanimously approved Sheppard's work on July 27, 1893.

Reinvigorated by Sheppard's cooperation, the monument association turned its focus on finances. The fundraising had not gone as well as hoped. Whether in confidence or despair the veterans turned as they frequently did, to their wives and daughters. They enlisted the help of several local ladies memorial associations, most notably the Oakwood Memorial Association and the Ladies Hollywood Memorial Association.

The LHMA had recently undertaken to acquire the former Confederate White House and was determined to open it as a "Confederate Museum" under the auspices of a new organization, the Confederate Memorial Literary Society. In April 1893 the ladies associations held a "Memorial Bazaar" in the Armory Building, 7<sup>th</sup> and Marshall Streets, in downtown Richmond. In 18 days they raised \$31,400, which they divided between their society (to fireproof the White House) and the Confederate Soldiers & Sailors Monument.

A list of receipts in the Association's account book indicated that the \$14,855.46 from the "Ladies' bazaar" represented more than half of the funds received for the monument. Thanks to the ladies, the Association was, it later confessed, "instantly relieved of all embarrassment and was enabled to push the work to completion, confident of their ability to pay the last dollar of its cost."

William Ludwell Sheppard signed a contract in August; he was paid \$10,000 for his work and recommendations. In December the artist wrote McCarthy, telling him that a clay model of the statue was ready for inspection. Under Sheppard's guidance, the committee contracted with a New York firm to produce the bronze statue, while a Richmond businessman successfully low-bid to construct the platform and stairs. The correspondence between McCarthy and Sheppard dealt with deadlines and monies, but retained a warm, cordial tone. Sheppard was reassuring to his "Dear friend McCarthy."

Now that the monument seemed a reality, on April 14, 1894 the Common Council, Board of Aldermen, and Mayor of

Richmond agreed to create a committee to cooperate with the Monument Association unveiling ceremonies. They set aside \$4,000 for aid "in such manner as will reflect credit on the City, and do honor to the men who so nobly laid their lives a sacrifice on the altar of their country."

But the course of committee work ne'er did run smooth, and, on May 7, 1894, a meeting was held to ponder the insufficiency of funds for the stairs, despite the mayor's approval for \$1,200 to go towards the same. With artist Sheppard present, it was moved and approved to have the statue face west or "up Main Street."

In the end, the stairs were built, the statue placed safely atop the plinth, and invitations issued for the unveiling ceremonies on May 30, 1894 (Memorial Day). The Richmond *Dispatch* pronounced it a "glorious day," despite the heavy rain that fell throughout the dedication ceremony. An estimated 100,000 people witnessed a parade of nearly 10,000 veterans, militia, and dignitary led by 2,000 children.

The official souvenir of the unveiling offered a sanitized history of the monumental effort that managed to avoid mentioning the name of Sir Moses Ezekiel.

It wasn't over for the association, of course, as they contended with the final expenses for the unveiling, including \$52 for ammunition, and \$50 for horse feed. The carpenter's bill of \$120.25 was considered "very excessive," and all the more aggravating because they refused to give an itemized account. The cost exceeded the mayor's \$4,000 allowance by \$725.22.

At its final meeting, on May 26, 1896, the Association voted to turn over its remaining funds (\$330) to the Jefferson Davis Monument Association and its records to the Confederate Museum. Secretary Carlton McCarthy went on to serve as Richmond's mayor 1902-1908, and likely found it easier work than the monument association effort.

Sir Moses Ezekiel lamented in his memoirs, "my heart was in the Southern cause; I fought for it and risked my life for it, but the injustice that had been done to me was very cruel. The blank ingratitude of my own people, however, could never change what I felt to be my duty towards my home and country."

Ezekiel got another chance to make his lasting mark and contribution on the Confederate landscape when he won the commission for the United Daughters of the Confederacy's richly symbolic Confederate monument in Arlington Cemetery. President Woodrow Wilson accepted Ezekiel's masterpiece on behalf of the American people in June 1914. Old soldier that he was, Ezekiel himself was buried in Arlington on March 30, 1921 at the foot of his own monument to the Confederacy. His tombstone bears the simple epitaph, "Moses Ezekiel, Sergeant, Company B,
