# THE COUNCIL OF THE CITY OF RICHMOND WELCOMES YOUR INPUT AND PARTICIPATION . . .

The City Council is the City of Richmond's local legislative body and is composed of one Council representative elected from each of nine districts. Council members are elected to serve a four year term of office. The Council elects one of its own to serve as the President and presiding officer for a two year term.

### **Time and Place of Meetings**

The City Council meets in **informal work session at 3:00 PM** and in **formal session at 6:00 PM**, on the second and fourth Monday of each month, in the City Hall 2nd Floor Council Chamber, located at 900 East Broad Street. **All meetings of the Council are open to the public.** 

#### Consent Agenda

Items listed on the Consent Agenda are considered routine and non-controversial. The consent agenda provides a method for the expeditious handling of items that do not require discussion and will be approved unanimously by a single roll-call vote of Council. The public may speak to any item on the Consent Agenda when the public comment period is announced by the President. Any person speaking to one or more items on the Consent Agenda will be allotted a total of three minutes.

#### **Citizen Comment Period**

The Citizen Comment Period is an opportunity for citizens to address Council concerning the services, policies, and affairs of the City and to discuss issues not on the agenda for the business meeting. However, you must schedule your appearance with the Office of the City Clerk no later than 12:00 noon on the date of the meeting. **Each speaker will be allotted three (3) minutes to make their comments.** 

An individual may appear before Council during the Citizen Comment Period no more than four (4) times per year and no more than once within a three-month period.

## **Guidelines for Citizen Participation \***

The maximum time allotted to persons speaking to any matter under consideration by the Council shall not exceed thirty (30) minutes for the proponents and thirty minutes (30) for the opposition.

Speakers should state their **full legal name**, any organization(s) they represent and any economic or professional relationship(s) that would benefit by the adoption of the paper(s) they are addressing.

Speakers will not be permitted to address or question the Chief Administrative Officer, the City Attorney, the City Clerk, or any staff member directly.

Questions should be directed to the President, who may at his discretion, solicit a response.

Applause is permitted during the Awards and Presentations Period only.

Persons speaking to Agenda items shall be limited to **three** (3) **minutes**; however, no individual from the public may speak for more than **ten** (10) **minutes total during the business meeting**.

Citizens may express their views in writing in lieu of an oral presentation.

Reasonable accommodations will be made to disabled citizens. Citizens are encouraged to contact the City Clerk's Office at 804-646-7955 for a "Request for Reasonable Accommodation" form which must be completed to receive assistance.

## THE CONSENT AGENDA

Items listed on the Consent Agenda are considered routine and non-controversial. The consent agenda provides a method for the expeditious handling of items that do not require discussion and will be approved unanimously by a single roll-call vote of the Council. However, the public may speak to any item, on the Consent Agenda when the public comment period is announced by the President.

- 1. Ord. No. 2013-80 (Patron: President Samuels, By Request) To authorize the special use of the property known as 2501 Monument Avenue for the purpose of a museum for architecture and design and a lodging unit, upon certain terms and conditions, and to repeal Ord. No. 2001-308-305, adopted Oct. 22, 2001.
- 2. Ord. No. 2013-96 (Patrons: President Samuels and Mr. Baliles) To amend ch. 2, art. III, div. 2 of the City Code by adding therein a new section 2-104, concerning reports to Council on economic development and lease matters, for the purpose of requiring certain activity reports with regard to negotiations relating to certain economic development and lease matters. Recommendation from Governmental Operations to continue to Thursday, July 25, 2013 Governmental Operations meeting. (Continue to Monday, September 9, 2013 Council meeting)
- 3. Ord. No. 2013-111 (Patron: Ms. Trammell) To set aside 44 parking spaces in the underground parking deck located on City-owned real estate at 900 East Broad Street for the City Council to use in its operations, with permission to occupy 40 of such parking spaces to be granted only by the Council Chief of Staff or the designee thereof and four of such parking spaces to be granted only by the City Auditor. Recommendation from Governmental Operations to approve w/amendments. (Continue to Monday, July 22, 2013 Council meeting)
- 4. Ord. No. 2013-112 (Patron: Mayor Jones, By Request) To amend Ord. No. 2004-216-272, adopted Oct. 11, 2004, which authorized the special use of the property known as 2623 East Broad Street for the purpose of converting an existing main building for use as three (3) dwelling units and a commercial space and converting the existing accessory building on such property into a dwelling unit, to reduce the restrictions placed upon the commercial space within the building, upon certain terms and conditions.
- 5. Ord. No. 2013-124 (Patron: Vice President Robertson) To amend and reordain City Code § 30-77, which assigns polling places in the city, to relocate and establish a new polling place for Precinct 610.
- 6. Ord. No. 2013-125 (Patron: Mr. Agelasto) To amend and reordain City Code §§ 30-114 and 30-116, concerning precinct boundaries for Precincts 503 and 505, for the purpose of establishing new precinct boundaries between such precincts.

- 7. Ord. No. 2013-131 (Patron: Mayor Jones) - To authorize the issuance of general obligation public improvement bonds of the City of Richmond in the maximum principal amount of \$11,250,000 to finance the cost of school projects and general capital improvement projects of the City for the following purposes and uses: construction, reconstruction, improvements and equipment for public schools; construction, reconstruction, improvement and equipment for various infrastructure needs, including traffic control facilities, streets, sidewalks and other public ways, bridges, storm sewers, drains and culverts, and refuse disposal facilities; participation in redevelopment, conservation and community development programs, including the construction, reconstruction, improvement and equipment for targeted public facilities included in these programs; construction, reconstruction, improvements and equipment for public institutional, operational, cultural, educational and entertainment buildings and facilities, including but not limited to the theaters, parks, playgrounds, cemeteries, libraries and museums; acquisition of real property therefor as appropriate; and the making of appropriations to the City's Economic Development Authority ("EDA") to be used by the EDA to finance capital expenditures or to make loans or grants to finance capital expenditures for the purposes of promoting economic development; and authorizes the Director of Finance, with the approval of the Chief Administrative Officer, for and on behalf of the City, to sell such bonds for such capital improvement projects, to provide for the form, details and payment of such bonds and to authorize the issuance of notes of the City in anticipation of the issuance of such bonds, and to authorize the issuance of taxable bonds, for the same purposes and uses, in the same maximum principal amount and payable over the same period as such general obligation public improvement bonds.
- 8. Ord. No. 2013-132 (Patron: Vice President Robertson, By Request) To amend and reordain Ord. No. 2012-102-104, adopted July 9, 2012, which closed to public use and travel, a portion of Virginia Street located between East Cary Street and an alley known as Exchange Alley, consisting of 5,529± square feet, conditioned upon the dedication to the City of property for alley purposes consisting of 3,161± square feet and of an easement over property for sidewalk purposes consisting of at least 745 square feet, upon certain terms and conditions, for the purpose of extending the deadline for compliance with the requirements of such ordinance.
- 9. Ord. No. 2013-135 (Patron: Mayor Jones, By Request) To close to public use and travel, a portion of right-of-way known as the 8<sup>th</sup> Street Connector located in the block bounded by South 8<sup>th</sup> Street, Basin Bank Street, South 9<sup>th</sup> Street and East Canal Street, consisting of 16,337± square feet, upon certain terms and conditions.
- Ord. No. 2013-140 (Patron: Mayor Jones) To amend the Fiscal Year 2012-2013 General Fund Budget by re-appropriating \$4,400,000 from the Fiscal Year 2010-2011 General Fund Budget fund balance excess to the Department of Information Technology in the amount of \$1,600,000 for Enterprise Resource Planning to provide for RAPIDS expenses; the Department of Police in the amount of \$1,800,000 for personnel costs related to vacations, resignations, retirements and terminations and for the Division of Emergency Communications to provide for the purchase of a hardware and software upgrade of the City's E911 telephone system and the purchase of Protocol Dispatch Software for the City's E911 Call Center; the Department of Public Works in the amount of \$500,000 for costs related to leaf pickup and vegetation control; and the Sheriff of the City of Richmond in the amount of \$500,000 for the cost of inmate medical services.

- 11. Ord. No. 2013-141 (Patrons: Mr. Baliles, Ms. Graziano and Ms. Mosby) To amend and reordain City Code § 110-136, concerning bus fares, for the purpose of increasing the CARE service fare and providing that CARE paratransit service will only be provided to the extent required by the Americans with Disabilities Act. Recommendation from Organizational Development to forward to July 16<sup>th</sup> Land Use, Housing and Transportation Standing Committee meeting. (Continue to Monday, July 22, 2013 Council meeting)
- 12. Ord. No. 2013-142 (Patrons: Mr. Baliles, Ms. Graziano and Ms. Mosby) To amend and reordain City Code § 110-136, concerning bus fares, for the purpose of increasing the CARE service fare and providing that CARE paratransit service not required by the Americans with Disabilities Act will be provided only from 6:00 a.m. until 8:00 p.m., Monday through Friday, and that such service shall not be provided on Saturday, Sunday or holidays observed by the Greater Richmond Transit Company. Recommendation from Organizational Development to forward to July 16<sup>th</sup> Land Use, Housing and Transportation Standing Committee meeting. (Continue to Monday, July 22, 2013 Council meeting)
