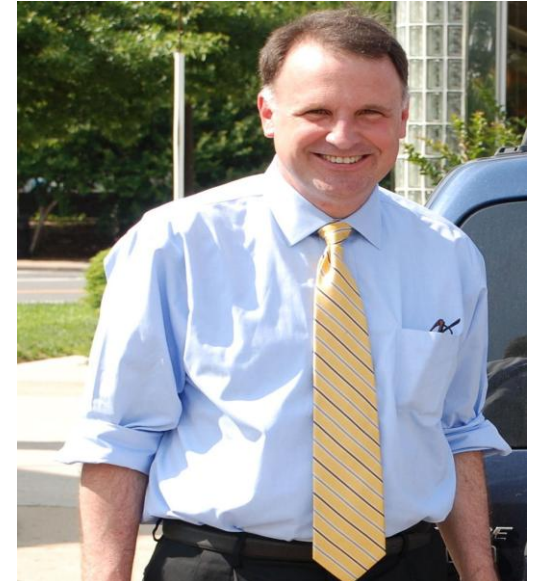

Walkwood Properties owners pled guilty Darrell Underwood, 43, and Cynthia Underwood, 41 both of Chesterfield, Virginia, was sentenced for their roles in a multi-million dollar fraud scheme.

According to court records, Darrell and Cynthia Underwood owned and operated Walkwood Properties. Walkwood properties were a real estate company that offered various home owners an opportunity to save their homes from foreclosure. Through that company, the Underwood's also offered an investment program to various individuals. They promised up to 50% return within 60-120 days. As a result of the Underwood's scheme, they received approximately \$18,400,000 in investor funds. Of that amount, the bank records established that only \$2,100,000 was actually paid towards any type of real estate transaction. Most of the invested money was used to repay earlier investors to keep the scheme going. It was also used for the Underwood's' personal expenses—among others for mortgage, car and boat payments as well as \$17,200. In church tithes. A number of the victims were taken in through church ties. Also, the Underwood's lived in an \$800,000 home and at one point scheduled a boat cruise for investors. The Underwood's investment program had an outstanding balance of over \$14,000,000 owed to various investors. Darrell received 120 months and Cynthia 36 months. Judge Spencer scheduled a final restitution hearing on the case for December 15, 2009

Towing rates could increase

The Richmond City Council is considering increasing the rates that towing companies can charge to remove vehicles from private property, even though some companies already have been charging more than the city ordinance allows. The city's maximum towing fee would be raised from \$65.00 to \$125.00. A recent investigation by the Richmond Police Department found that some towing companies have been charging excessive fees when they tow and store illegally parked vehicles from private property. The city also wants to increase the daily storage fee from \$20.00 to \$35.00 after the first 24-hour period and allow a \$30.00 administrative fee for vehicles not picked up within 72 hours. The proposal also would clarify what fees would apply if the owner of a vehicle arrives before the vehicle is towed off. In that situation, a \$30.00 fee to release would be charge.

Many low income citizens have lost their vehicles to towing company because of all the fees added while they are trying to raise the money to get their car. Fees should stay at \$65.00 and there should be a 5day grace period to give citizens an opportunity to find out who towed their vehicle and pay the fees.

City Council should protect citizens from towing companies that prey on the community. Also, a good tip is if you have an accident or broke down, have your vehicle tow to your home or to your mechanic because if you don't the towing company is going to charge you every day that your vehicle sits on their lot.

Amos 'N Andy Show



Like many of its early television counterparts, the Amos 'n' Andy television program was a direct descendent of the radio show that originated on WMAQ in Chicago on March 19, 1928, and eventually became the longest-running radio program in broadcast history. Amos 'n' Andy was conceived by Freeman Gosden and Charles Correll, two white actors who portrayed the characters Amos Jones and Andy Brown by mimicking so-called Negro dialect.

Amos 'n' Andy was first broadcast on CBS television in June 1951 after a 30 year run on radio. The TV show lasted some two years before the program was canceled in the midst of growing protest by the black community. It was the first television series with an all-black cast and the show was nominated for a Primetime Emmy for Best Situation Comedy.

To some the characters in Amos 'n' Andy, including rude, aggressive women and weak black men were offensive. Neither The Kingfish nor Sapphire Stevens could engage in a conversation without peppering their speech with faulty grammar and mispronunciations. Especially abhorred was the portrayal of black professionals. The NAACP, bolstered by its 1951 summer convention, mandated an official protest of the program. The organization outlined a list of specific items it felt were objectionable, for example, how "every character is either a clown or a crook," Negro doctors are shown as quacks," and "Negro lawyers are shown as crooks." As the series appeared in June 1951, the NAACP appeared in federal court seeking an injunction against its premiere. To network executives, the show was harmless, not much different from Life with Liugu, The Goldbergs, or any other ethnically oriented show of the times. In 1953, CBS reluctantly removed the program from the air, but not solely because of the efforts of the NAACP. This period in America history featured a swiftly changing climate for race relations in the United States. Consideration for the southern market was of great concern to major advertisers. In an era when African Americans were becoming increasingly vocal in the fight against racial discrimination, large advertisers were reluctant to have their products too closely associated with black people. Fear of White economic backlash was of special concern to advertisers and television producers. So, television said good bye to Amos "n" Andy.

Nat Love a.k.a Deadwood Dick



Nat Love and his Family


Nat Love was born June 14, 1853 as a slave on Robert Love's plantation in Tennessee. Love would grow up to be one of the most famous cowboys in the Old West. In 1869, Love left his family and went to Dodge City, Kansas and joined the Duval Ranch after breaking the wildest horse they had. The 16 year old quickly adapted to life of a cowboy, showing excellent skills as a ranch hand and practiced so often with a .45 revolver that his shooting skills also became very good. After three years with Duval Outfit, Love moved on to Arizona in 1872, where he went to work for the Gallinger Ranch on the Gila River. There he traveled many major western trails, sometimes working in dangerous situations in Indian battles and fighting off rustlers and bandits. During these years as an Arizona cowboy, Nat was referred to as Red River Dick and claimed to have met many of famous men of the West including Pat Garrett, Bat Masterson and Billy the Kid.

In the spring of 1876, the Gallinger cowboys were sent to deliver a herd of three thousand steers to deadwood, South Dakota. When the crew arrived on July 3d, the locals were busy preparing for a 4th of July celebration. One of the many organized events included a "cowboy" contest with a \$200.00 cash prize to the winner. The contestants competed in roping, bridling, saddling, and shooting. Winning every competition, hands down, Nat walked away with the \$200 prize and the nickname of "Deadwood Dick."

Nat continued to work as a cowboy in the southwest for another 15 years before he began to settle down and got married in 1889. The next year he took a job in Denver and Rio Grande Railroad. As such, he worked on the routes west of Denver and moved his family several times to Wyoming, Utah, and Nevada before finally settling down in southern California.

In 1907, Nat Love published his autobiography, The Life and Adventures of Nat Love, Better Known in the Cattle Country as "Deadwood Dick" a tale that tended to take on the epic proportions more noted in the many "dime novels" of the time. Though he boasts in the book that everything actually happened, there is very little external verification, such as those famous western men that Love allegedly met.

In other cases, there are no records for the cattlemen that he said he worked with and for. As to what portion of the book is fact and what is fiction will never be known; however, that didn't stop the American public, hungry for tales of the west, from avidly reading the book. Love's last job was working as a courier for the General Securities Company in Los Angeles, California.

RICHMOND SPOTLIGHT

How Richmond City Council became majority black in 1977?

Curtis J. Holt Sr. was a social activist who challenged the imposition of a moral code through subsidies and other forms of state funding. He is most notable for the changes he brought to local governance in Richmond, Virginia. In 1972 Richmond City council elections were suspended after Holt filed a lawsuit challenging the city's annexation of part of Chesterfield County. This annexation was part of a large movement called Massive Resistance, and was an attempt by the largely white city council to retain a white majority in the city during a time of immense white flight. Holt argued that the annexation diluted black voting power.

Curtis Holt Sr. and the Richmond Crusade for Voters was the major force in the mobilization of the black community from the years of quiet desperation under Democrat Harry F. Byrd's political machine. The Richmond Crusaders of Voters made up primarily of black middle-class male professionals led the struggle for black political representation. In 1977, federal courts ordered a plan to replace the at-large voting system for the council with a larger city council divided into nine wards. The result was a black-majority city council that then elected Henry Marsh as the city's first black mayor.

How Richmond City Council became majority white in 2008?

The majority black council started off good, but for some reason some became unaccountable and not accessible to the community. Some forgot they were black, some went to jail, and some just didn't do anything. You be the judge. Let's think about it, if you got 6 black votes out of 9 you should be able to pass any bill you present if you work together. You can vote to put more money in the schools, you could vote not to raise taxes, you can vote not to give money to projects unless it serves all communities. You could have voted not to give 25 million dollars to Crestar Bank or 30 million dollars to Center stage. You could have voted on reasonable rent for 6th street market place so the businesses could have survived or you could have made the permits reasonable for the street vendors without putting them out of business too. You could have cut some of the red tape so people would want to open a business in Richmond. You could have voted to put money in summer programs for the youth and you also could have made sure money made it back to the minority communities. You could have voted not to add so many fees to light, phone or water bills. You could have voted for the city to stop outsourcing soon much business outside of Virginia when jobs are needed here. You could have helped many of the minority businesses that had to close because real dollars never made it to minority communities. If you could have invested 5 millions in the youth then you wouldn't have overcrowding in the jail now. They could have made a difference!

Between Deeds and McDonnell there is over 15 million dollars in this Virginia election being circulated and minorities are not given the same opportunity to make money at a time when so many families are in need.

CASANEGRA: A Tennyson Hardwick Novel**

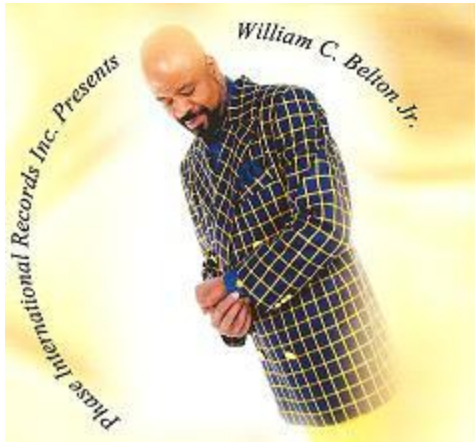

Let me begin with an unconventional, yet simplistic: Wow...what a remarkable, roller-coaster ride of a story! I was barely through the first chapter before I found myself captivated with protagonist, Tennyson Hardwick, and now I can't wait to read his next happenstance detective adventure. Write-brain to paper doesn't create flawed-hero, implausible (yet, believable) characters like Hardwick for just ONE episode. So surely there's got to be another novel in the works. About: Former gigolo, and struggling actor, Tennyson Hardwick's quest to find out who murdered his former client, successful rap artist/actress, Serena Johnston (alias Afrodite), presents an action-packed storyline that successfully presents such real-life scenarios as: the complex relationship between Hardwick and his ailing father; Serena's relationship with her no-talent sister and jealous, deceptive childhood friends; and, the occasional senseless violence often depicted in today's hip-hop culture. Filled with a cadre of intriguing characters: some lethal, a few pathetic, (and one or two who made me want to jump into the book and slap them upside the head), CASANEGRA literally leaped off the pages, transferring itself into a mind-movie that kept me enthralled up until the ending. In this reviewer's opinion, Underwood's collaboration with Due and Barnes is electrifyingly-creative. To this end (or beginning), I look forward to these three churning out more Tennyson Hardwick novels. On my Author's Scale of one through ten – with one being devastatingly-bad and ten being awesomely-wonderful – CASANEGRA: A Tennyson Hardwick Novel is off the Richter scale, scoring a well-earned ten-and-a-half!

WHERE DID BLACK RADIO START

America's first black radio with an all Black on-air staff that programmed Black music all day is WDIA in Memphis, Tennessee. In the fall of 1948, WDIA began assembling its air staff with DJs like Rufus Thomas, Dwight "Gatemouth" Moore, and "Hod Rod" Hulbert. 1070 WDIA is still a premiere station in the Memphis area and continues to be the #1 station serving the African American community.

The first black owned radio station was WERD Atlanta in October 1949. Jesse B. Blayton Sr., a well-respected businessman and accountant from Atlanta purchased it in the late 1940's, and hired his son Jesse Jr. to run it. Also hired was "Jockey" Jack Gibson, among the most popular black DJs. The station was housed in the Masonic building on Auburn Avenue, then one of the wealthiest black neighborhoods in the United States. Jack "The Rapper" Gibson-The Father of Black Radio. He helped start the first Black owned and operated radio station in America. Jack the rapper is also credited with developing a new design for radio control rooms where he elevated the equipment forcing disc jockeys to stand. In the early 1960's Jack left radio and began to make his mark in the record industry. His pioneering efforts brought many in the Black music profession together. He put together his first music convention in 1977. Jack The Rapper became known within today's Hip Hop circles with his music convention in Atlanta. It was considered to be the first Black Music convention and it was soon the template for the numerous others to follow. Jack Gibson passed away from cancer in February 2000. It's ironic, that Jack, Jocko and Frankie Crocker all pioneers in Black radio passed away in 2000. Next month August Moon talks about his friend Jack the Rapper.

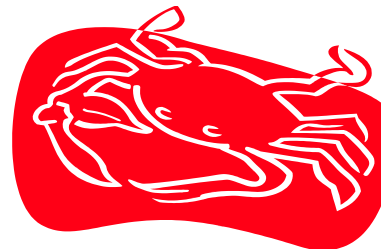
